#### SECTION 5 : FIRE-FIGHTING MEASURES

##### 5.1 EXTINGUISHING MEDIA:

Extinguishing powder or CO<sub>2</sub>. In the case of more important fires, also alcohol resistant foam and water spray/mist. Do not use for extinguishing: direct water jet. Direct water jet may not be effective to extinguish the fire, since the fire may spread.

EXPOSURE CONTROLS:

ENGINEERING MEASURES:



Provide adequate ventilation. Where reasonably practicable, this should be achieved by the use of local exhaust ventilation and good general extraction. If these measures are not sufficient to maintain concentrations of particulates and vapours below the Occupational Exposure Limits, suitable respiratory protection must be worn.

Protection of respiratory system: Avoid the inhalation of vapours.

Protection of eyes and face: It is recommended to install water taps, sources or eyewash bottles with clean water close to the working area.
