7.1 PRECAUTIONS FOR SAFE HANDLING:

ENGINEERING MEASURES:











Provide adequate ventilation. Where reasonably practicable, this should be achieved by the use of local exhaust ventilation and good general extraction. If these measures are not sufficient to maintain concentrations of particulates and va pours below the Occupational Exposure Limits, suitable respiratory protection must be worn.

Protection of respiratory system: Avoid the inhalation of vapours.

Protection of eyes and face: Install water taps, sources or eyewash bottles with clean water close to the working area.
