MIXTURE PREPARATION:	MIXTURE PROPORTION in volume (5:1):		
	Component A5 Parts		
	Component B1 Part The two components have to be intensively mixed, respecting the indicated proportions, with the use of mechanical means of slow rotation speed (300-400rpm) during 3-5 minutes. To keep in mind that the mixture lifetime can varies between 1 to 2 hours, according to the environment temperature.		
SURFACE PREPARATION:	Very often, the pellicular defects of the paints are the consequence of a deficient surface preparation. Therefore, before the application, to make sure that the surface is dry, clean, free of rust or dirt, and properly degreased. Stripping by sandblasting by degree Sa 2 ½ is the ideal. Important: to apply NEUCEROCK HS100 as fast as possible after the surface preparation to prevent any contamination. Do not leave the stripped steel without protection during night. In cases of contamination, to remove all the contaminants and to strip again the zones whenever necessary. Over cementitious surfaces, to make sure that the concrete is totally cured and without any contamination.		
APPLICATION:	The mixture is realized with an airless spray-gun (preferably) or conventional, but it can also be applied with a paintbrush or a roller in one or two coats, properly diluted.		
DILUTION:	With "EPOXY DILUENT", in the following approximated proportions:		
	Paintbrush, roller and airless spray-gun0 - 5% Conventional Spray-gun5 - 10%		
CLEAN-UP:	With "EPOXY DILUENT" or "CELLULOSE DILUENT", right after the application.
