



A1 – WATER BASED VINYLIC INSULANT

DESCRIPTION:



This product is based on vinyl copolymers, suitable for a use on walls insulation, either on the interior or on the exterior, before the use of acrylic finish paints.

FEATURES:

- Good resistance to alkalis (anti-alkaline)
- Good penetration on plaster and good sealing capacity
- Good power binder even in powdery plasters.
- Excellent adhesion to the supports

RECOMMENDED **USE:**

Used on walls insulation, both interior and exterior, as a first insulate layer of our wide textured and acrylic paints range.

The insulate application on very absorbent structures is essential, to avoid the grinding effect due to the selective vehicle absorption.

SURFACE PREPARATION: The new plaster has to be properly clean, dry, hard, without any dirt, mosses and free of badly-adhered sands.

Concerning repaints, the surface has to be clean, brushed and

without any traces of badly-adhered or exfoliating paint.

APPLICATION:

Before to use mix energetically the product.

The application is to be realized with a roller, a paint-brush or a

spray-gun, in a single coat.





DILUTION: Is supplied ready to use.

COVERAGE: Variable according to the support's absorption, and the application

conditions.

On average and per coat of $8 - 10 \text{ m}^2 / \text{liter}$.

CLEAN-UP: With water right after the application.
